## ELIGIBILITY

**An invitation to all WISCONSIN professional Artists** and WISCONSIN residents for whom Fine art is an avocation. Must be 18 years and older.

**All 2D and 3D fine art...**paintings, sculpture, ceramics, jewelry, photography, textiles, prints, fiber, art glass, hand-crafted furniture, woodcarvings, metal work, and mixed media encompassing the broadest possible range of art forms.

- \* Must be framed and ready to hang/display
- \* Must NOT have been shown before in Gallery 110 North
- \* Must be original and created within the last three years
- \* The Fine Arts Committee will have the final word on appropriateness of work and will not accept computer enhancements or alterations, or computer digital-generated art.
- \* White or neutral colored mattes please
- \* Framed and floor display 3-D pieces may not exceed 6'X6'
- \* Wall-hung pieces may not exceed weight of 30lbs
- \* Sculpture and floor display pieces must be light and stable enough, to be easily carried by two persons

**Nell Emerson Jarosh** Executive Director and Co-owner of Edgewood Orchard Galleries, Fish Creek, Wisconsin. Founded in 1969, Edgewood Orchard Galleries is one of the Midwest's most respected art galleries.

## AWARDS

**\$1,000 in cash awards from the Joan Kohn Memorial Fund will be presented.** Awards will be determined at the juror/judge's discretion from actual artwork.

## LIABILITY

**All work will be insured by the PAC while in the care of the gallery.** Artist is responsible for shipping and insurance costs to and from the gallery. Submission of this application form constitutes the agreement to all conditions listed in this prospectus.

## SALES

**Artists are encouraged to place their work for sale.** If a piece of artwork is sold, a tax deductible donation of 35% of the sale price must be made to the PAF by the artist. Sold work must remain in the gallery the entire length of the exhibition.

### ENTRY PROCESS ✓ boxes

- Complete application form
- Include a slide of each entry or images of up to three(3) entries on one CD
- Include \$25 entry fee (covers up to 3 entries)
- Postmark deadline **March 22, 2008**
- Enclose self-addressed stamped #10 envelope, or larger envelope if CD is to be returned

## ENTRY PROCESS

- \* \$25 Entry fee is non-refundable
- \* No exceptions to the entry process
- \* Jurying done by 35mm slides and digital images provided as a jpeg file on CD
- \* A close-up of 3D work may be included
- \* Submit in slide sleeve or individual holder (no glass mounts)
- \* Label slides: artist's name, title of work, media, size (HWD), place red dot in lower left front corner of slide
- \* Self-addressed stamped #10 envelope or larger to be used for juror results and return of non-included slides/CD

## DELIVERY & RETURN

- ✓ boxes
- Label** accepted artwork on back. Place Label at the bottom of the piece with: artist's name, title, media, price or NFS
- Shipped work must arrive in a pre-paid, reusable container the **week of April 14-18**
- Deliver artwork **Saturday April 19 from 9:00-3:00PM** to Gallery 110 North located in the Plymouth Arts Center (corner of Mill and North Streets)
- Return of shipped artwork by the same carrier **week of June 16-21**
- Pick up artwork **SUNDAY, June 15, 4-6pm** or **MONDAY, June 16, from 9am-3pm**
